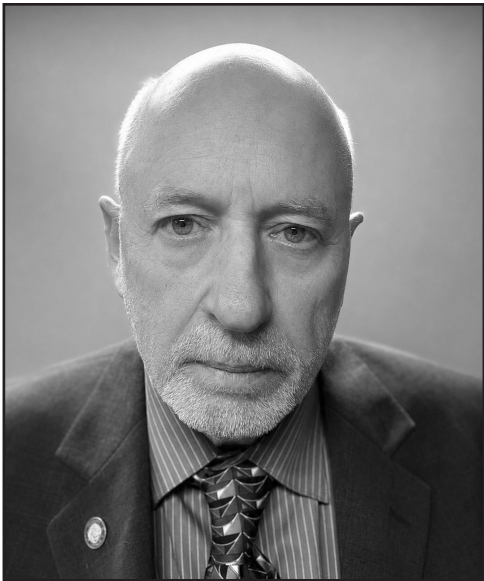

Policy Positions for District 20

Paul's core platforms:

Public safety must be Anchorage District 20's top priority. Families should feel secure in their homes, children should be safe walking to school, businesses should be protected from theft and vandalism, and parks and trails should remain open and welcoming.

Anchorage must respond firmly to violent crime, repeat offenders, drug trafficking, and chronic public disorder. At the same time, homelessness, addiction, and mental illness cannot be solved by arrest alone. We need a balanced approach that combines enforcement with treatment, accountability, and measurable results.

I support stronger coordination among police, prosecutors, courts, treatment providers, and community organizations so offenders do not fall through jurisdictional gaps and people in crisis are directed toward effective services. Public funds should support programs that reduce crime, restore stability, and help people return to productive lives, not systems that simply manage the problem year after year.

Government's first duty is to protect the public while respecting constitutional rights, due process, privacy, and equal treatment under the law. Safe neighborhoods are the foundation for better schools, stronger businesses, affordable housing, and a healthier community.

I also support expanding Alaska's healthcare workforce, strengthening home and community based senior care, improving assisted-living coordination, and reducing administrative waste. Better care transitions, telehealth, caregiver support, and accountable funding can help seniors remain independent while easing pressure on hospitals, families, and emergency services.

Education must emphasize literacy, accountability, classroom discipline, parental transparency, and career pathways that prepare students for Alaska's future.
