STATEMENT:

Nick Begich went to Washington to fight for Alaska, not to become part of the failed system. In Congress, Nick is focused on unlocking Alaska's resources, lowering costs for working families, creating Alaska jobs, protecting our communities, and making sure Alaskans have the freedom to chart our own course.

In his first term in Congress, Nick Begich helped pass major tax relief for working Alaskans, including no taxes on tips, no taxes on overtime, historic tax relief for seniors, and permanent relief for small businesses.

Nick also helped secure the most significant federal resource wins for Alaska in a generation. Through the Working Families Tax Cuts Act, Congress reopened major opportunities for responsible energy development in the National Petroleum Reserve-Alaska, Coastal Plains, Cook Inlet, and other resource areas critical to Alaska's future.

Nick also secured a stronger long-term deal for Alaska by increasing the state's share of certain federal resource revenues from 50 percent to 70 percent. This means more of Alaska's resource wealth stays with Alaskans, helping support PFDs, classrooms, roads, public safety, and essential services across the state.

As a businessman, Nick does not believe Alaskans should have to ask D.C. bureaucrats for permission to use the resources beneath our feet. His next fights are clear: advance the Alaska gasline, end the regulatory chokehold for good, and build a generation of high-paying jobs that keeps our kids and grandkids home.
