STATEMENT:
Yes. Politics in Juneau today is just as slimy and distasteful as you have heard, and perhaps more so. Because of that, I must ask for more than just your vote today. A vote simply changes the name of one politician for another. Unfortunately, we need to do more than that or we risk mortgaging the freedoms and opportunities of future Alaskans.

This year legislators spent 70% of the PFD. The role of a statesman is to defend the rights and interests of the public, particularly from special interests. That battle cannot be won without the support of everyday Alaskans when decisions are being made in Juneau.

Politicians talk about being honored at election time. Once you've fought in the trenches in Juneau against the special interests you realize that it's not about you, and it doesn't feel very much like an honor when you are being shot at politically simply for standing up for everyday Alaskans in Juneau. My family and I were forced to personally pay more than \$300K in legal costs just to defend your rights in Juneau. We are committed.

I aspire to never back down from defending your rights. Even the smallest among us deserve protection. Compromises should further the public interest, not sell out one group of voters for the benefit of another group that is more politically connected. Officials often avoid taking difficult votes. I do not. I voted on every bill since I was first elected. I ask for your support.
