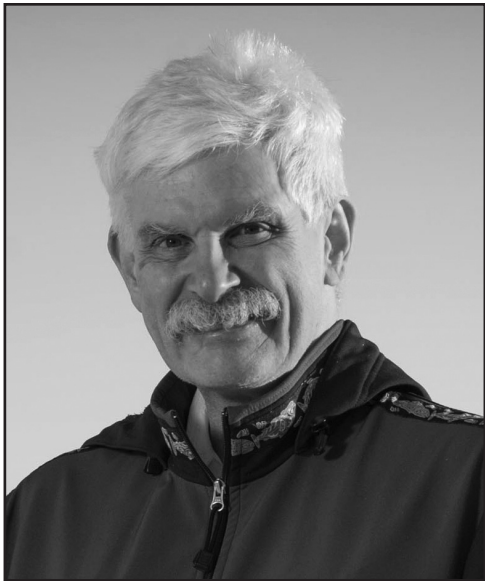

STATEMENT:
Right now, families are feeling the squeeze. From Government Hill to Muldoon, groceries cost more, rents are rising, and childcare and energy bills keep climbing. At the same time, our state continues to struggle with decades of fiscal uncertainty. It's clear we cannot keep putting off the hard decisions.

Our community needs fully funded public education, safe neighborhoods and roads, and a state government that invests responsibly in its future.

I've spent much of my career working on the challenges facing our state. I helped write and get passed the law creating the Permanent Fund Dividend because I believe Alaska's resource wealth should benefit every Alaskan. I also worked on legislation that strengthened our state's finances and later served as a prosecutor protecting children and families. As a legislator, I introduced and got passed legislation creating the Military Family Help Center in the Alaska Department of Military and Veterans Affairs. This legislation helps connect military families and veterans to resources in Alaska.

As your next legislator, I'll work hard to get our state's finances in order so we can invest in our communities again. I'll protect our PFD, work to diversify state revenue, and make smart budget decisions that respect taxpayer dollars.

I'm running because North Anchorage needs practical, proven leadership. We need someone that will work across the aisle, who understands the needs of our district, and is willing to fight for them. I would be proud to earn your vote.
