Position Statement

I am pro-life and believe that life begins at conception. As a legislative aide, I worked on pro-life legislation and remain committed to protecting the unborn. I strongly support the Second Amendment and the right of law-abiding citizens to keep and bear arms. In 2023, I carried HB61, Limitation on Firearm Restrictions, on behalf of Representative Tilton in response to COVID. The bill was signed into law. I support Alaska's statutory Permanent Fund Dividend. The Legislature should either follow the law as written or change it through the legislative process—not ignore it. Alaska's education system is not meeting the needs of many students and families. Parents should have a meaningful voice in what their children are taught and where they receive their education.

Education funding—including transportation and special needs funding—should follow the student, allowing families to choose the educational setting that best serves their child's needs. Alaska has a spending problem, not a revenue problem. State government spends too much on programs that lawmakers believe people need instead of allowing Alaskans to make those decisions for themselves. More resources should remain in the hands of families, and government should focus on its core responsibilities. There are programs that can be reduced or eliminated with little impact on Alaskans.
